
Smt. Bratati Harichandan, IAS(Rtd) Commissioner SCPD, Govt. of Odisha

He discoursed from VGuard Industries Ltd. portrayed an extensive landscape of the company's Corporate Social Responsibility (CSR) engagements specifically tailored for Odisha. His narrative vividly highlighted VGuard's unwavering dedication to supporting communities during times of disaster, showcasing the company's swift and substantial aid in calamities.

The Navadarshan Project, in collaboration with the Odisha Rising Foundation, stood out as a testament to VGuard's commitment to addressing intellectual disabilities, showcasing their investment in impactful collaborations for societal welfare. Their active involvement in bolstering educational institutions underscored their holistic approach to community development. The announcement of "SUNO," a forthcoming initiative targeting the empowerment of the hearing-impaired populace in Odisha, illustrated VGuard's proactive stance toward inclusivity. This initiative signals the company's innovative resolve to uplift and improve the lives of those with hearing impairments, further solidifying their commitment to creating positive societal change.

A Session on Cause & Treatment Opportunities for PwDs – Technicality



Dr. Kusum Dash, Gynecologist , Kalinga Hospital

a seasoned Obstetrics and Gynecology Consultant at Kalinga Hospital Ltd., discussed the critical factors leading to congenital anomalies, specifically highlighting the profound influence of maternal infections and illnesses on fetal development. She emphasized the necessity of early identification by outlining crucial prenatal tests and interventions. Dr. Dash detailed trimester-specific precautions and interventions, advocating proactive prenatal care as an essential approach in mitigating potential birth defects and genetic anomalies for the well-being of both mothers and infants.



Dr. Ankita Bhagat,

Pediatric, **Kalinga Hospital** a Consultant Neonatologist and Pediatrician at Kalinga Hospital Ltd, illuminated the various categories of disabilities and their distinctive care requirements, particularly during childbirth and the early phases of a child's life. Stressing the importance of skilled healthcare personnel during delivery and immediate post-birth care, Dr. Bhagat emphasized the significance of early childhood interventions. She underscored comprehensive rehabilitation measures encompassing physical, educational, and economic facets, advocating for an inclusive environment and specialized services for children with disabilities.

The insightful discussions by Dr. Kusum Dash and Dr. Ankita Bhagat at the Odisha Inclusive Summit 2023 shed light on crucial aspects of maternal health, fetal development and early childhood care. The call for comprehensive rehabilitation measures and an inclusive environment echoed the need for holistic support and specialized services to ensure the well-being of children with disabilities. Both discussions emphasized the significance of early interventions and proactive measures in ensuring a healthier future for mothers and children alike.

Panel Discussion 2

Inclusion of Health and Education / Corporate responsibility in enhancing employability and inclusion of PwDs in workplaces

In the Panel Discussion 2 of the Odisha Inclusive Summit 2023, the conversation was divided into two significant themes: Inclusion of Health and Education, and Corporate Responsibility towards enhancing employability and fostering inclusion of Persons with Disabilities (PWDs) in workplaces. Shri. Akshaya Biswal, representing Heifer International, took charge as the moderator, guiding the discourse toward strategies aimed at fortifying inclusion in health and education sectors specifically tailored for PWDs.

In the panel discussion, Shri. Manish Kumar Pandey of Infosys Foundation, Shri. Bijoy Ketana Panda from TCS, and Prof. Narayana Pati of Chetana contributed a multifaceted view on the role of corporations in fostering inclusive workplaces for Persons with Disabilities (PWDs). Each panelist highlighted various aspects of corporate responsibility in shaping environments that are accommodating and supportive of PWDs.



Shri. Manish Kumar Pandey Trustee of Infosys BBSR CSR Group

He representing Infosys, passionately highlighted the imperative of fostering supportive work environments within corporations for Persons with Disabilities (PWDs). His insights revolved around the essential elements needed for inclusivity: adaptable infrastructure, inclusive policies, and a culture valuing diversity that ensures equal opportunities for PWDs.

Shri.Pandey emphasized the need for organizational awareness programs and sensitization sessions to cultivate an inclusive atmosphere that nurtures talent equally, offering a clear career path and requisite training. His emphasis on a respectful environment across sectors and the provision of special interview panels for PWDs echoed the need for a holistic approach to foster happiness and success among employees.



Shri. Bijoy Ketana Panda, Manager, TCS, Bhubaneswar

Shri. Bijoy Ketana Panda, representing TCS, delved into the pragmatic execution of programs dedicated to integrating Persons with Disabilities (PWDs) into diverse industries. His focus was on devising and implementing specialized initiatives tailored to address the unique needs and skill development of PWDs, thereby ensuring their smooth integration into the workforce. Shri.Panda highlighted the pivotal role of targeted training programs and the adaptation of work processes to create viable employment avenues for PWDs.

Additionally, he shed light on the critical importance of physical, digital and social accessibility, pinpointing existing gaps in legislation that fail to specify the percentage of PWDs to be employed in corporate or private sectors. He advocated for the establishment of Employ Resource Groups (ERG) as a potential solution, emphasizing the need for legal clarity and support to bridge these gaps for the comprehensive inclusion of PWDs."



Prof. Narayana Pati

Secretary of Jewel International School

He provided insights into Chetana's strategic approach to corporate responsibility, emphasizing skill enhancement, job readiness, and career development for Persons with Disabilities (PWDs). His discussion revolved around initiatives targeting the augmentation of skills and aligning them with industry requirements. Pati highlighted collaborative endeavors with corporations, aiming to bridge the gap between the skill sets possessed by PWDs and the demands of different sectors.

Additionally, he underscored the significance of inclusive education, emphasizing the need for comprehensive infrastructure and teaching aids in schools. He stressed the importance of provisions such as special educators in each school, high-quality training for special education teachers and the widespread adoption of software-based education to facilitate an inclusive learning environment. Mr.Pati's multifaceted insights aimed to address systemic gaps and promote inclusive education practices that pave the way for the holistic development of PWDs.



Ms. Abha Mishra, State Head UNDP

Her perspectives as a panelist from UNDP, the discussions highlighted critical points that demand our immediate attention. MS. Mishra emphasized the necessity to prioritize understanding the needs of PWDs and shifting our focus from solely providing help to fostering inclusion. Addressing the shortage of expertise and special educators, she stressed the importance of redefining language and technology approaches to better serve the diverse needs of PWDs.

Ms. Mishra commended initiatives such as TCS, recognizing their impactful approach that transcends mere voluntarism, emphasizing the need for a comprehensive impact assessment model that others should emulate. She underscored the importance of actively including Persons with Disabilities (PWDs) in all facets of society rather than solely providing assistance. Her recommendations align with this vision, advocating for clear and concise policies to facilitate inclusive practices, a comprehensive understanding of disabilities, enhanced and accurate data collection for informed decision-making, the implementation of a certain percentage of reservations in corporations for inclusivity, prioritizing accessibility improvements, promoting awareness campaigns to challenge societal perceptions, biases, and explicitly defining inclusion strategies for PWDs in corporate Terms of Reference (ToR). Ms. Mishra's insights illuminate the path toward a more inclusive and equitable society.

Ms. Mishra highlighted UNDP's commitment to inclusivity by providing spaces that cater to special needs, urging for a more inclusive society.

The trajectory outlined by Ms. Abha Mishra underlines the essence of the Odisha Inclusive Summit2023, by Odisha Rising Foundation—a dedication to reshaping societal structures, policies, and mindsets. It's a call to action for sustained dialogue, policy reforms and concerted efforts across sectors, steering us toward a more inclusive future, where every individual's potential is celebrated and realized.

Collectively, the panelists emphasized the necessity for corporations to embrace inclusive practices, from fostering accommodating work environments to implementing specialized programs that equip PWDs with the necessary skills for meaningful employment. Their discussions highlighted the pivotal role of corporations in driving societal change towards greater inclusivity and equity for PWDs in the workforce.



Shri Akshaya Biswal ,Heifer International:

In his concluding remarks as the Moderator, emphasized several pivotal takeaways from the insightful discussions. Foremost among them is the imperative need for a profound shift in societal mindsets toward inclusivity, recognizing it as a critical factor for transformative change.

He stressed the importance of continued discourse on inclusivity, emphasizing that sustained and ongoing conversations are indispensable for driving meaningful and enduring changes in societal perceptions. Furthermore, Shri Biswal underscored the significance of awareness and visibility, noting that the summit report's public accessibility is crucial. This visibility ensures that the report reaches government authorities and the media, thereby amplifying its impact and fostering broader awareness of the issues discussed during the summit.

The discussions held during the summit delved comprehensively into various facets of fostering inclusivity, particularly within health, education, and corporate sectors. Central to these discussions was the shared understanding that collaborative efforts and strategic initiatives are pivotal in amplifying opportunities and integration for Persons with Disabilities (PWDs).

The discourse consistently underscored the importance of collective action and a unified approach in tackling the challenges faced by PWDs. The overarching aim remains the creation of a more inclusive, accommodating and equitable society.

Panel Discussion 3

NGO Initiatives, shaping inclusive communities for PwDs – Focusing more on skill building & employability

The diverse panelists, including, Shri. Sameer Nair from Youth 4 Jobs, Shri. Kumar Raju from UNFPA, Prof. Ulrike Zeshan from UCL, UK, Shri. Sibaji Panda representing Happy Hands and Md Azim ud Doula from Quest Alliance shared insightful perspectives on how their respective organizations are actively engaged in shaping inclusive communities for PWDs.



Shri. Sameer Nair, Operations Head, Youth4 Jobs emphasized the pivotal role of NGO initiatives in fostering sustained growth and development for Persons with Disabilities (PWDs) on multiple fronts. He shed light on the intricate challenges that go beyond the scope of government initiatives, emphasizing the crucial interventions carried out by NGOs at various levels. According to Shri.Nair, the seemingly straightforward goal of skill-building and employability entails a multi-layered process that necessitates advocacy and mindset shifts across diverse communities.

He articulated a comprehensive strategy focusing on two fundamental aspects: advocacy within communities with disabilities and the economic empowerment of PWDs through sustainable livelihoods. Shri.Nair stressed the imperative need for a systemic mindset change within educational institutions, promoting an environment conducive to the active participation of PWDs in educational schemes. His approach emphasized creating opportunities at multiple levels, including altering institutional mindsets and fostering inclusive educational spaces through peer group integration. Additionally, Shri.Nair advocated for policies that not only promote the hiring of PWDs but also ensure their sustained opportunities, irrespective of any mandated quotas, by sensitizing employers and society at large. He underscored the importance of accessibility beyond physical infrastructure, highlighting the need for inclusive workplaces and adaptive technology. Shri.Nair's approach emphasized comprehensive skill development tailored to different educational levels, ranging from basic literacy to advanced vocational courses, aimed at providing diverse PWDs with the requisite skills for meaningful employment. Ultimately, he articulated that NGOs focusing on mindset change, accessibility, skill development, and employment could substantially enhance the integration of PWDs into mainstream society.



Shri. Kumar Raju (UNFPA) expressed gratitude to ORF for providing an invaluable platform to address the diverse needs of children with disabilities across different life stages. He emphasized the evolving needs of children, citing various stages requiring distinct interventions: from therapeutic and medical necessities during early childhood (ages 0-6) to specialized education and eventually economic independence in adulthood.

Shri.Raju underscored the pivotal role of skill development, not only in Odisha but nationwide and globally, as a fundamental pillar for the employability of individuals with disabilities. He referenced international legal frameworks such as the UNCRPD and Goal 8 of the SDGs, emphasizing their focus on vocational training and rehabilitation, reinforced by national legislation like the Rights of Persons with Disabilities Act, 2016, particularly Section 3 emphasizing vocational rehabilitation and economic activities.

Highlighting NSSO data from 2011, Shri.Raju pointed out that over 52% of persons with disabilities fall into an employable age group, necessitating access to skill training for economic engagement. He commended the efforts of both the Government of India and the Odisha state government for their initiatives, notably mentioning the exemplary Special ITI in Jatni, setting a benchmark for inclusive employability training. Stressing the significance of early skill development, Shri.Raju advocated for integrating skill-building into school curriculums, encouraging children's interests and hobbies to transform into valuable skills that could be pursued as careers.

He emphasized the need for standardized course curricula across various trades, tailored vocational training based on individual abilities, and proper evaluation before imparting job-specific training. Raju stressed the importance of catering to diverse disabilities, including intellectual impairment, urging the government to bolster efforts to provide skill training centers for such individuals. He concluded by underlining the need for inclusive skill development programs catering to the visually impaired, hearing impaired, and intellectually impaired, ensuring equitable opportunities for all disability types. Within the context of UNFPA's initiatives, Raju highlighted their commitment to



Prof Ulrike Zeshan from UCL, UK: Gratitude was extended to ORF for the gracious invitation to the splendid program. The cultural performances, especially the captivating Sambalpuri singing and dancing, were thoroughly enjoyed. Throughout the day, important discussions unfolded, and a concise summary was prepared to encapsulate these crucial points.

Recurring throughout the day were discussions on identifying existing gaps. One speaker in the morning emphasized the need to consider an ecosystem approach, citing the insights shared by representatives from TCS, Infosys, academic professionals, and education experts. The perspective highlighted that solutions are not derived from singular software packages or gadgets but rather from an interconnection of various elements—a genuine ecosystem approach.

Drawing from her extensive 25-year engagement with the deaf community in India, she highlighted the evolution of understanding over time. Initial endeavors often faltered due to an inadequate comprehension of the ecosystem. Currently, she is involved in research in the UK, exploring ecosystem change. This research extends beyond the deaf community to embrace a broader context, akin to ecosystem management for poverty reduction or climate change. Deaf culture has instilled invaluable methods—visual aids, collaborative settings, chalks, and posters—essential elements in building and disseminating an effective ecosystem. Settling in Odisha alongside Happy Hands School, she and her husband have fostered an ecosystem encompassing education and ecology, exemplified by their residence in Sikha village.

Their efforts have materialized into an interconnected ecosystem—a school for 50 children amidst chemical-free farming practices, symbolizing a serene, harmonious garden. Their NGO's distinctive advantage lies in the absence of profit-driven targets, allowing meticulous work over five years to craft this ecosystem. However, the challenge persists in scaling and replicating this ecosystem model across diverse contexts. Conventional initiatives in international development often falter due to their narrow focus on singular issues, failing to embrace the holistic ecosystem approach.

As they navigate these challenges, there emerges a critical need for a unifying theory and method to propagate ecosystem models universally. Their ongoing pursuit involves devising these frameworks, ensuring that every place can foster its unique, effective ecosystem—a testament to their relentless dedication to this transformative cause.



Shri. Sibaji Panda (Director, Happy Hands School for the Deaf, Subarnapur)

Addressed the audience with gratitude, acknowledging the efforts of the ORF team and volunteers contributing tirelessly throughout the day. He highlighted the diverse mix of people present, including NGOs, government officials, academicians, and corporate individuals, all contributing to the discourse on disability.

Sharing his personal journey of acquiring deafness later in life, he expressed that despite facing fewer barriers himself, he understood the challenges profoundly. He stressed the need for addressing societal problems rather than framing disability as a personal issue.

"First, fix the problems within society—lack of ramps, educational inadequacies, and workplace barriers—before attempting to 'fix' us," he urged. Emphasizing his imminent pursuit of a Ph.D., he asserted his capability to overcome any obstacle. He challenged the notion that the deaf community's educational deficiencies were the cause of the disability, noting that their deaf school functioned effectively. Shri.Sivaji called for dignity in addressing the gaps within the ecosystem, particularly in educational realms, advocating for a successful deaf education system.

Reflecting on his efforts in Delhi and elsewhere, he expressed frustration at not being heard and recognized despite proposing impactful changes. He lauded the presence of interpreters in the Odisha summit, emphasizing the necessity of qualified interpreters in deaf education.

Shri.Sivaji then delineated the approach of his school, Happy Hands, emphasizing its integration with the mainstream system. He rejected the labeling of their institution as a "special school," emphasizing their use of sign language within their ecosystem. Shri.Sivaji passionately spoke about the challenges faced in implementing a localized approach in rural areas, safeguarding their educational sanctity from external disruptions. He emphasized unity and integrity within their community.

The talk culminated with Shri.Sivaji's poignant plea for fair treatment, respect, and acknowledgment of individual capabilities, asserting that when the ecosystem is inclusive, employability becomes an inherent outcome.

Contrasting this perspective, Shri. Sibaji Panda (Happy Hands) from the Happy Hands organization elaborated on holistic strategies for nurturing skills and talents among PWDs, emphasizing creative mediums for skill development and showcasing their potential for substantial contributions.



Shri. Azim ud Doula (Quest Alliance): In the reverberating halls of the Summit, he found himself immersed in the invaluable insights shared by the esteemed speakers, Shri.Sivaji and Prof.Erika.

While he may not hail from the realm of PWDs, his journey at Quest Alliance, dedicated to empowering the youth across the nation, has been profoundly enlightening. The courage required crafting programs that embrace and work alongside individuals with disabilities is immense. Learning from the experiences shared by Shri.Sivaji and Prof.Erika to infuse inclusivity into their initiatives is a beacon of aspiration. When confronted with the topic of 'inclusion,' he found himself questioning the term 'disability' itself. Despite improvements highlighted by data—only 2% of the 75 lakh enrolled students are classified as having a disability—he strongly believes this percentage falls short.

Delving into the study of inclusion, he discovered a new dimension. Beyond persons with disabilities, women and minority communities also face exclusion. True inclusion demands consideration of the entire ecosystem. Discrimination, stigma, and decision-making failures persist as barriers. Yet, the onus partly rests on civil society, often seeking funds but shying away from bold recommendations. He firmly believes in their responsibility to create and champion recommendations that catalyze change. They must move beyond mere physical infrastructure, looking deeper into specialized training and transforming mindsets. It's an arduous journey, but civil society's role is pivotal in challenging norms and recommending novel solutions. Demonstrating possibilities is equally crucial.

For schools to become more accommodating to those with disabilities, teacher training is imperative. With UNESCO reporting that 330 million lack access to basic hygiene while discussing ramps, there's a stark contrast in priorities. Engaging students in such endeavors shouldn't be seen as an optional activity; it must become an integral part of their education.

In his dedicated work with schools, he has carefully considered a range of strategies to promote inclusion. Firstly, he advocates for engaging school leaders actively in this transformative journey, recognizing their pivotal role in effecting change. Emphasizing the importance of a vision for inclusion within schools, he works towards fostering an environment that prioritizes diversity and embraces differences. Additionally, providing teachers with specialized training on managing small or peer groups is a cornerstone of his approach, empowering educators to create inclusive learning environments. The establishment of reflection circles within school premises serves as a practical tool for introspection and continuous improvement. However, he acknowledges that there is much more to be accomplished, emphasizing the necessity of collaborative efforts involving NGOs, corporate social responsibilities (CSRs), and governmental bodies to bring about meaningful and sustainable change in the educational landscape.

Each panelist's insights converged on the common goal of promoting skill-building, employability, and fostering inclusive communities for Persons with Disabilities, underscoring the impactful role of NGOs in driving these initiatives forward. Their collective efforts aim to break barriers and create opportunities for meaningful engagement and empowerment for PWDs.








Cultural event by PWDs

"Empowerment through Inclusion" Recommendations from Odisha Inclusive Summit 2023

Skill Building Programs for PWDs' Employability:

One of the key outcomes of the Odisha Inclusive Summit 2023 was the emphasis on skill-building initiatives tailored specifically for Persons with Disabilities (PWDs).
